NOTIFICATION

Pursuant to the orders of the Honorable Peshawar High Court dated 21-08-2022 in writ petition No. 1576-P/2021, teaching of Mutaliae-Quran Hakeem (for Muslims) and Ethics (For Non-Muslims) has been made compulsory from the current Academic Session 2022-23 in classes 9th and 11th and subsequently in 10th & 12th from the next Academic Session 2023-24 and onwards.

Since TSC and D.Com/ DBA have been declared equivalent to SSC and HSSC respectively, therefore the subject of Mutaliae-Quran Hakeem for TSC Part-I and D.Com / DBA Part-I shall be taught from the Academic Session 2022-23 and subsequently for TSC Part-II and D.Com / DBA Part-II classes the said subject shall be taught from the next Academic Session i.e. 2023-24 and onwards.

The Directorate of Curriculum and Teacher Education, Khyber Pakhtunkhwa Abbottabad being the competent forum, vide its Notification No. 5275-89/89/ADL.CTR/F.64/Vol-I/SOS/ECE-XII dated 28/11/2022 has Notified the marks allocation for these subjects as under.
